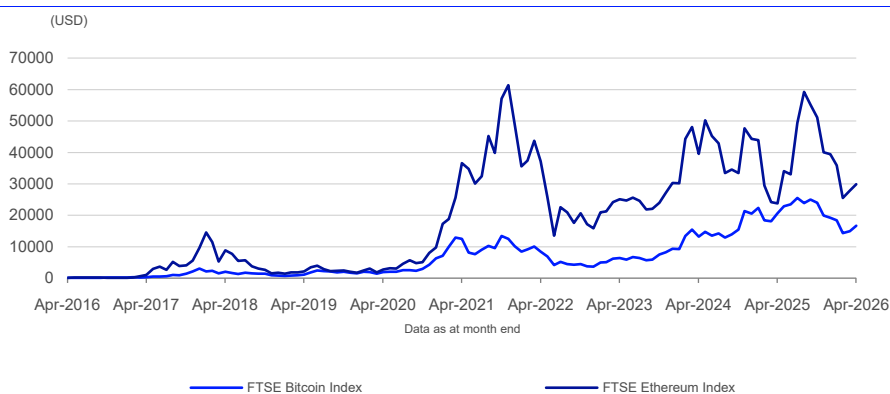

FTSE Russell has partnered with Digital Asset Research to develop the FTSE Digital Asset Index Series to represent the investable Digital Asset market. The FTSE Bitcoin Index, which is part of the FTSE Digital Asset Index Series, reflects the settlement price of Bitcoin as determined by the FTSE DAR Reference Price. The Index is calculated on an hourly basis from Sunday 00:00 UTC to Friday 23:00 UTC. The index reflects price levels and does not incorporate any network events such as forks. The index was designed to meet the requirements of EU BMR and UK BMR. FTSE is the Benchmark Administrator for the index.

The FTSE Digital Asset Index Series leverages the FTSE DAR Reference Price-Benchmark Assets price data. This underlying pricing employs a methodology designed to capture data from vetted exchanges. In addition, fundamental to the index methodology, ongoing monitoring of exchanges and assets is provided by Digital Asset Research.

The performance charts and tables in this factsheet are based on daily USD denominated index values for 22:00 UTC.
