

United Maritime Corporation (USA): Special Cash Dividend

30 November 2022

United Maritime Corp (USA, BMZ4BN0) is expected to pay a special cash dividend of USD 1.00 effective 11 January 2023. This exceptional distribution will be subject to 30.00% Withholding Tax.

FTSE Russell intends to apply a special cash dividend (capital repayment) of USD 1.00 and in order to accommodate this event in the net-of-tax indexes, FTSE Russell proposes to make an XD adjustment in the calculation of the total return indexes at the close on 10 January 2023. This would be consistent with a portion of the cash dividend being required to pay the tax liability.

Clients should note that this treatment will be applied to all total return indexes, and not just the net-of-tax indexes.

Calculation of the total return adjustment below:

Tax liability: USD 1.00 * 30.00% = USD 0.3 (tax liability)

A negative dividend of USD 0.428571428571429 will be applied to the FTSE Russell standard Total Return Indexes (i.e. USD 0.3 / 70.00%) in order to reflect this tax adjustment.
