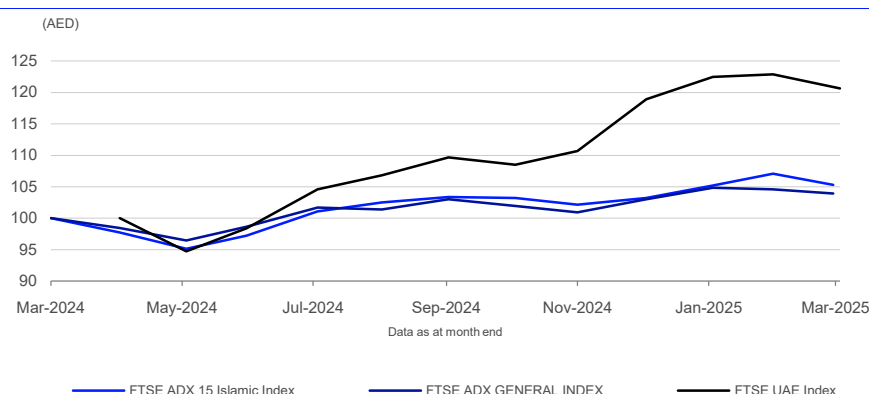


FTSE ADX 15 Islamic Index

The FTSE ADX 15 Islamic Index is based on the FTSE ADX General Index and has been designed to be used as the basis of Shariah compliant investment products that meet the requirements of Islamic investors globally. The FTSE ADX 15 Islamic Index represents the top 15 eligible companies and screened by IdealRatings, who are responsible for ascertaining the Shariah compliance of constituents of the Index.

Coverage

The universe of eligible constituents are all the companies that are constituents of the FTSE ADX General Index.

Objective

The index is designed for the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Capping

Largest company capped at 33% with all other companies capped at 18%. Implemented at the quarterly reviews.

Transparency

Index methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and total return methodologies, both real time and end-of-day.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
