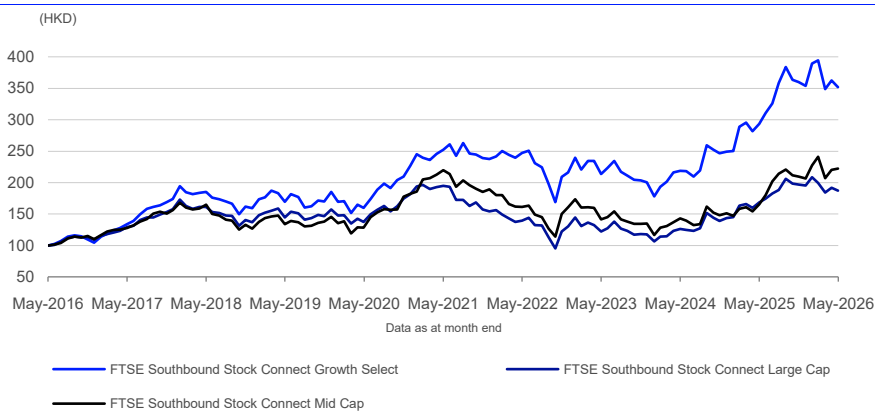


# FTSE Southbound Stock Connect Growth Select Index (HKD)

The FTSE Southbound Stock Connect Growth Select Index is designed to represent the performance of companies in the FTSE Southbound Stock Connect Index that demonstrate strong growth potential and competitive advantages. It comprises the top 50 eligible securities by a Growth Composite Score, which integrates expected earnings growth, earning momentum, operating net income margin and free cash flow margin. Constituents are weighted by free-float market capitalization.

## FEATURES

### Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

### Investability

Stocks are selected and weighted to ensure that the index is investable.

### Liquidity

Stocks are screened to ensure that the index is tradable.

### Capping

Constituents are capped at 15%, and the sum of largest 5 constituent weights capped at 60%

### Transparency

The index uses a transparent, rules-based construction process. Index Methodologies are freely available on the FTSE Russell website.

### Availability

The index is calculated based on price and total return methodologies.

### Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
