About the index

The Russell 1000® Growth Benchmark Index measures the performance of US large cap growth stocks. It includes US large cap stocks with relatively higher price-to-book ratios, higher 2-year I/B/E/S forecast growth and higher historical 5-year sales growth. The index is reconstituted fully in June to ensure accurate representation of the US large cap growth style, with updates for parent index membership changes in December and quarterly IPO inclusions in March and September. Index constituent weights are not capped.

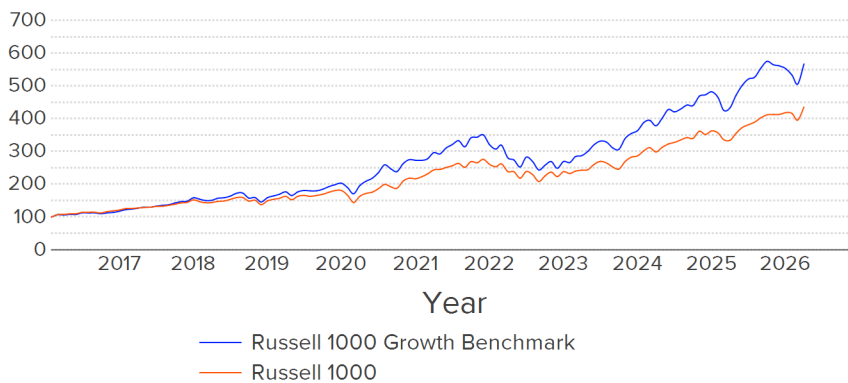

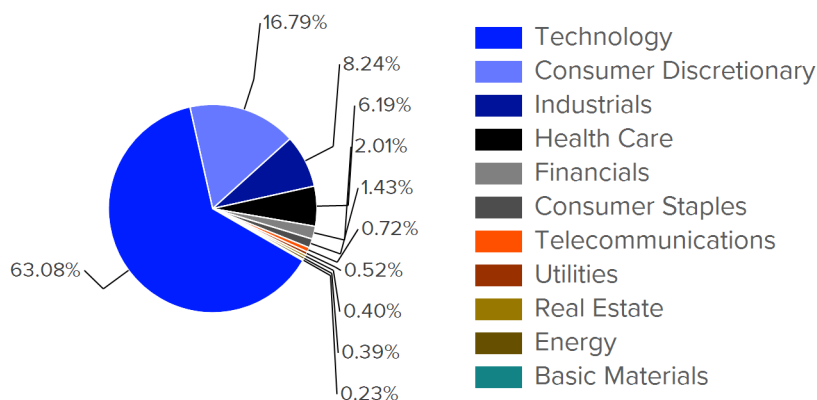
