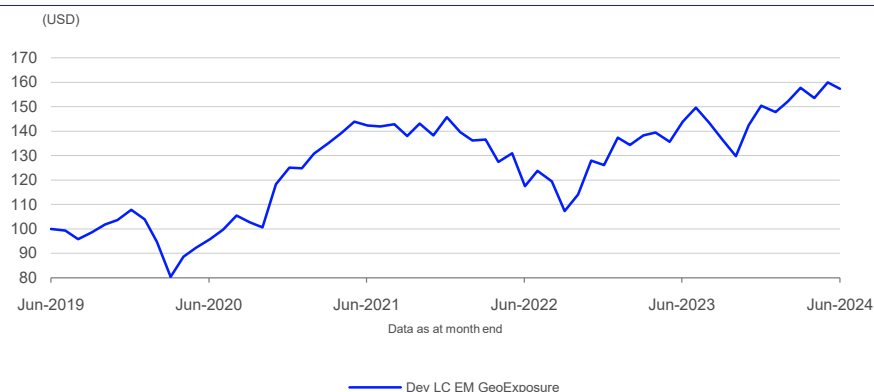


# Russell Developed Large Cap EM GeoExposure Index

The index uses a transparent, rules-based construction process. Index Rules are freely available on the FTSE Russell website.

### Availability

The index is calculated based on price and total return methodologies, and available end of day.
