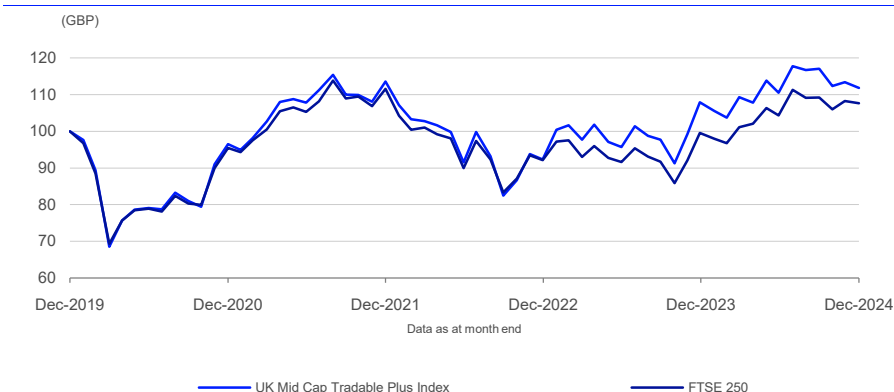


FTSE UK Mid Cap Tradable Plus Index

Availability

The index is calculated based on price and total return methodologies, both real time intra-second and end of day.
