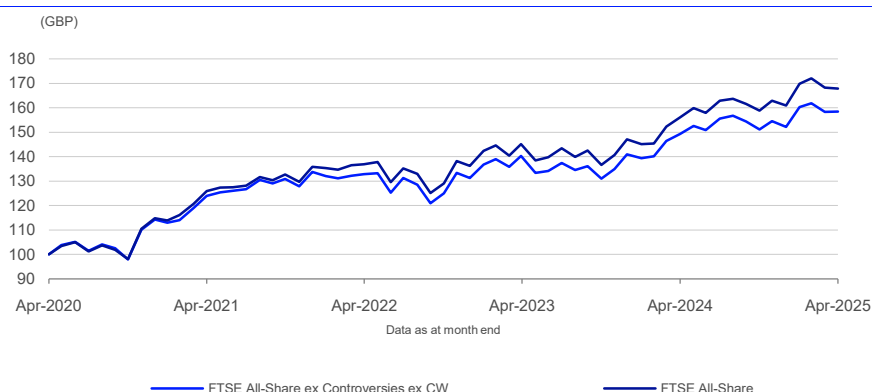


# FTSE All-Share ex Controversies ex CW ex Tobacco ex Therman Coal (10%) Index

The FTSE All-Share ex Controversies ex CW ex Tobacco ex Therman Coal (10%) Index measure the performance of the FTSE All-Share Index after excluding the companies involved in Weapons (Chemical & Biological, Cluster Munitions, Anti-Personnel Mines), Tobacco or generating greater than 10% of their revenues from thermal coal extraction and/or electricity generation. The index also exclude companies based on Controversial Conduct. The index is part of the FTSE Global Choice Index Series, which is designed to help investors align their values with their investment choices by selecting companies based on the impact of their products and conduct on society and the environment.
