

FTSE Ping An China A Free ESG Advanced 100 Index

The FTSE Ping An China A Free ESG Index series integrates Ping An's China specific ESG scores to reflect the performance of companies demonstrating strong environmental, social and governance practices (ESG) in China. The FTSE Ping An China A Free ESG Advanced 100 Index selects the top ten companies ranked by Ping An's ESG score from each of 10 ICB industries (financials and real estate are considered as one combined industry) and weights the constituents by market capitalisation. The underlying FTSE China A Free Index is a free floated adjusted benchmark designed to represent China A Shares available for domestic Chinese investors, incorporating stocks listed on the Shanghai and Shenzhen Stock Exchanges including the Shanghai STAR Board and the Shenzhen ChiNext Board.

Capping

The constituents of FTSE Ping An China A Free ESG Indices are capped at 10% at each review.

Transparency

The index uses a transparent, rules-based construction process. Index Methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and total return methodologies, available end of day.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
