

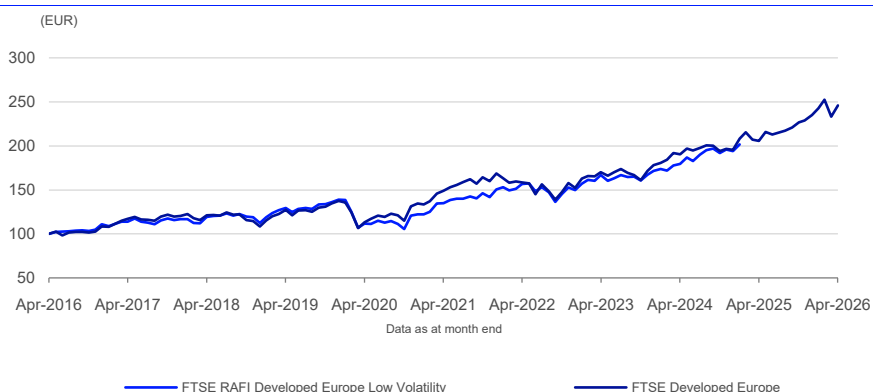
FTSE RAFI™ Developed Europe Low Volatility Index

Prices and market values are not determinants of the index weights. Consequently the indexes are less prone to excessive concentration arising from market fads, which can result in over-exposure to individual companies, sectors or countries.

Index rules are freely available on the FTSE Russell website.

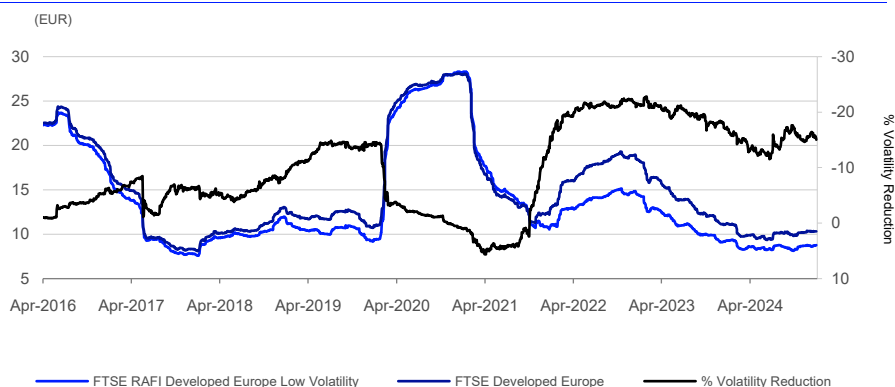
Availability
