

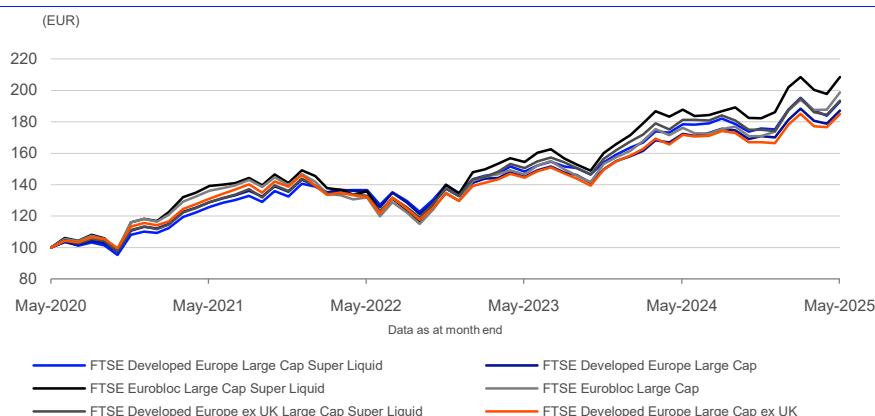
FTSE Developed Europe Large Cap Super Liquid Indices

- Create a basket which closely mirrors the characteristics of the parent index.
- Maintain diversification across industry segments.

FEATURES

Coverage

Super Liquid versions of the FTSE Developed Europe Large Cap, FTSE Developed Europe Large Cap ex UK and FTSE Eurobloc Large Cap Index indices.

Objective

The indices are designed for the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Capping

Stocks are capped at 10% if necessary on a quarterly basis (UCITS Compliance).

Liquidity

Stocks are screened to ensure that the indices are tradable.

Transparency

The indices use a transparent, rules-based construction process. Index Rules are freely available on the FTSE website.

Availability

The indices are calculated based on price, net and total return methodologies, both real time and end-of-day.

Industry Classification Benchmark

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
