

# FTSE UK 100 ESG Select Index

The FTSE UK 100 ESG Select Index is designed to measure the performance of the top 100 companies, as demonstrated by their Environmental, Social and Governance (ESG) practices, within the FTSE All Share Index. This index uses the overall Score from FTSE Russell's ESG Ratings and data model to select companies for inclusion. Companies are weighted by investable market capitalisation.

## **Objective**

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

#### Investability

Stocks are selected and weighted to ensure that the index is investable.

#### Liquidity

Stocks are screened to ensure that the index is tradable.

## **Transparency**

The index uses a transparent, rules-based construction process. Index Methodologies are freely available on the FTSE Russell website.

## **Availability**

The index is calculated based on price and total return methodologies, available end of day. A net of tax version of the index is also available.

## **Industry Classification Benchmark (ICB)**

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
