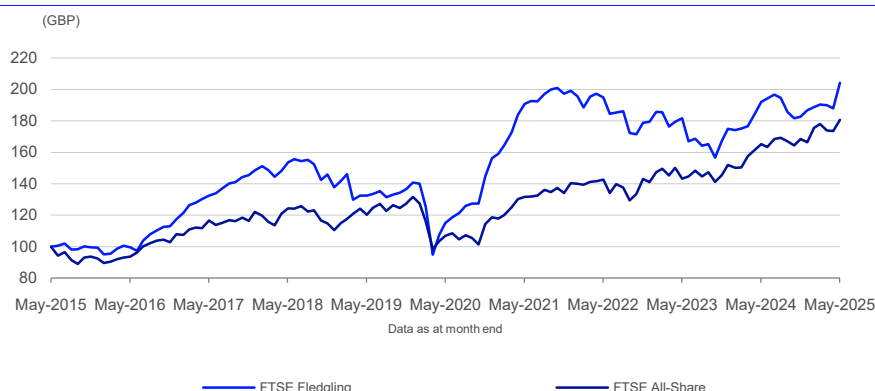


FTSE Fledgling
