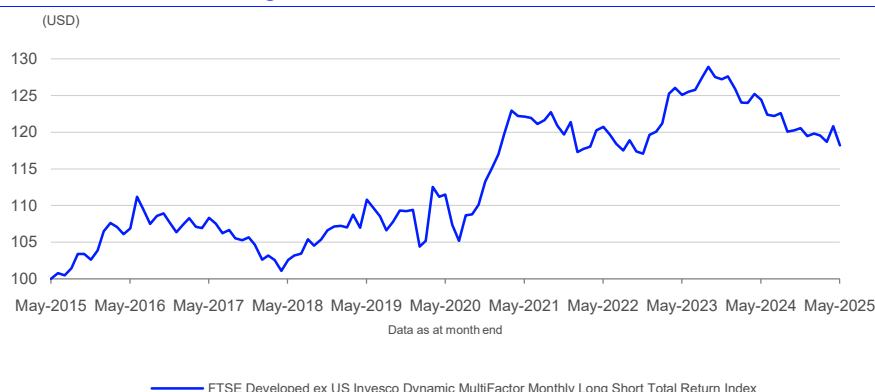


FTSE Developed ex US Invesco Dynamic MultiFactor Monthly Long Short Total Return Index

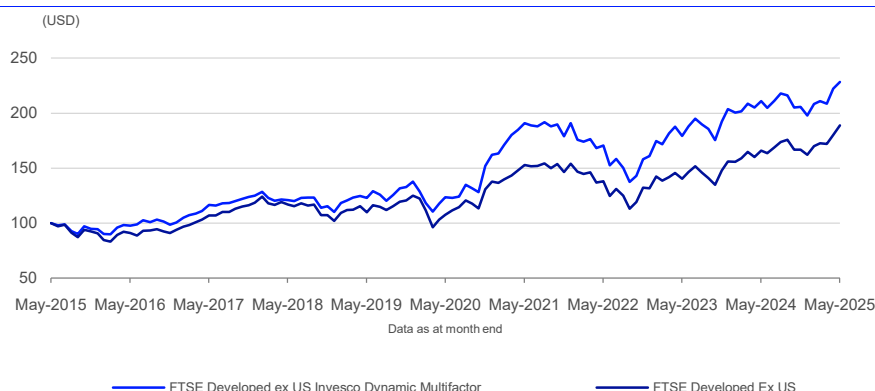

The FTSE Developed ex US Invesco Dynamic MultiFactor Monthly Long Short Total Return Index reflects the performance of a combination of component indices with different weights: the FTSE Developed ex US Invesco Dynamic MultiFactor Index (+100%) and the FTSE Developed ex US Index (-100%). Component weights are rebalanced monthly.

Coverage

Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

Liquidity

Stocks in the underlying index are screened to ensure that the index is tradable.

Transparency

Index methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and total return methodologies, both real time and end-of-day.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
