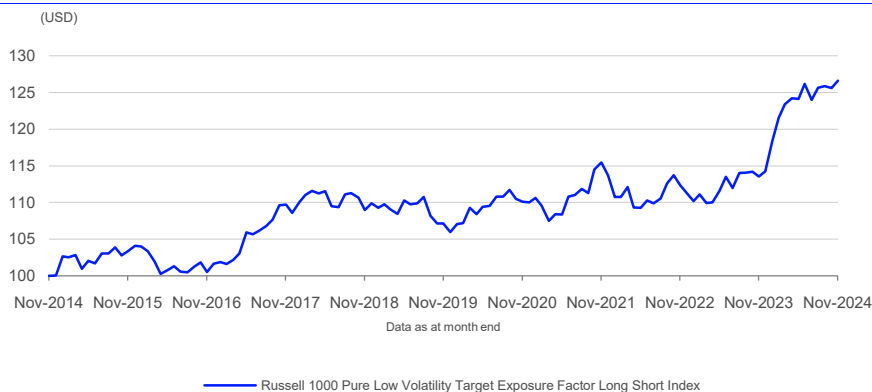


Russell 1000 Pure Momentum Target Exposure Factor Long Short Index

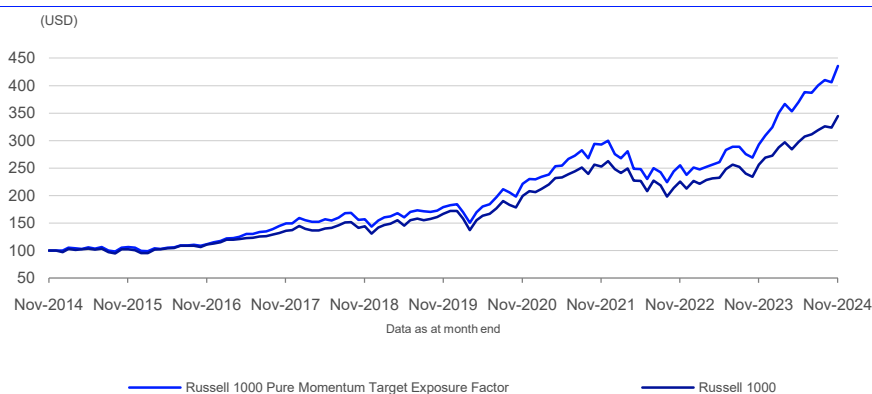

The Russell 1000 Pure Momentum Target Exposure Factor Long Short Index reflects the performance of a combination of component indices with different weights: the Russell 1000 Pure Momentum Target Exposure Factor Index (+100%) and the Russell 1000 Index (-100%). Component weights are rebalanced monthly.

Coverage

The index is calculated based on price and total return methodologies, both real time and end-of-day.

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
