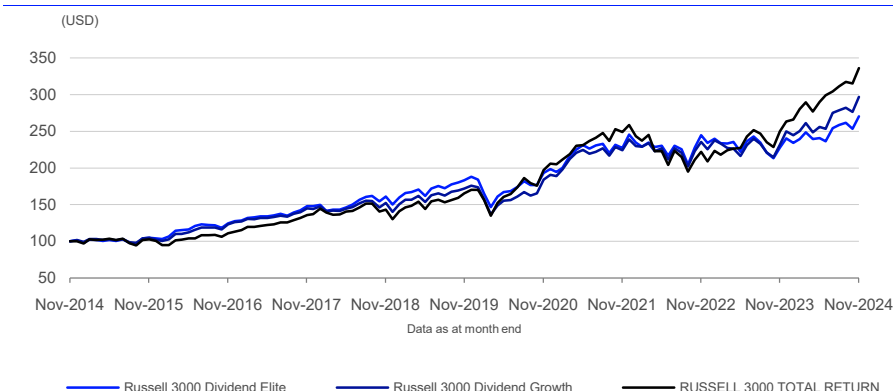


# Russell 3000<sup>®</sup> Dividend Elite Index

The Russell 3000 Dividend Elite Index measures the performance of investable securities within the small, mid and large cap segment of the US market. The index is designed to capture companies that have successfully increased their dividend payments over a period of thirty-five years. The index is rebalanced to equal weight on a quarterly basis.
