

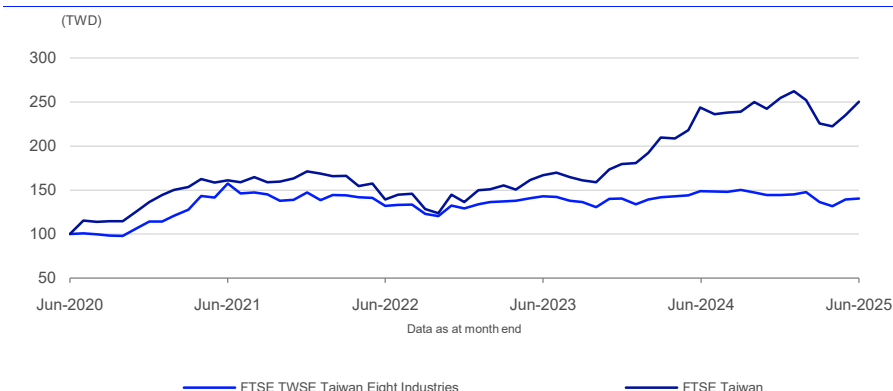
FTSE TWSE Taiwan Eight Industries Index

FTSE Group has partnered with the Taiwan Stock Exchange (TWSE) to calculate the FTSE TWSE Taiwan Index Series, combining both local knowledge and international indexing capabilities, to create a family of eight indices for both domestic and international investors.

The FTSE TWSE Taiwan Eight Industries Index, represents the performance of key industry sectors in the Taiwan stock market, based on the combined constituents of the FTSE TWSE Taiwan 50 and FTSE TWSE Taiwan Mid-Cap 100 indices. The eight industries included in the index are Energy, Basic Materials, Industrials, Consumer Staples, Health Care, Consumer Discretionary, Telecommunications, and Utilities.

FEATURES

Coverage

The eight industries included in the index are Energy, Basic Materials, Industrials, Consumer Staples, Health Care, Consumer Discretionary, Telecommunications, and Utilities.

Objective

The indexes are designed for the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

The index uses a transparent, rules-based construction process. Index methodologies are freely available on the FTSE Russell website.

Availability

The indexes are calculated based on price and total return methodologies, both real time and end-of-day.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
