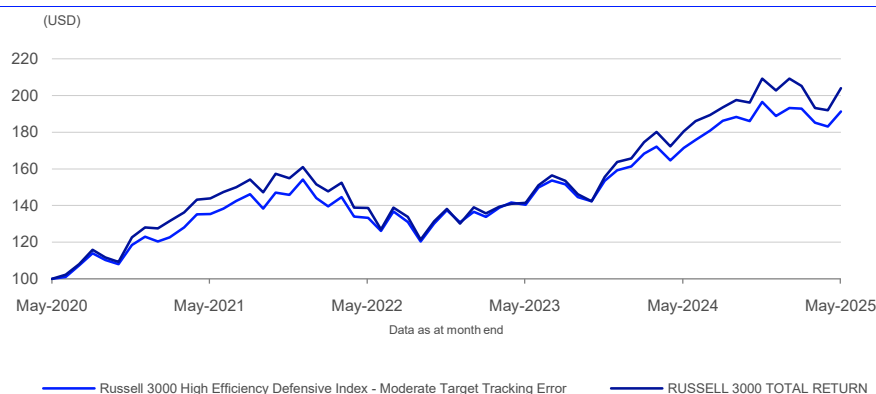


# Russell 3000 High Efficiency™ Defensive Index® - Moderate
