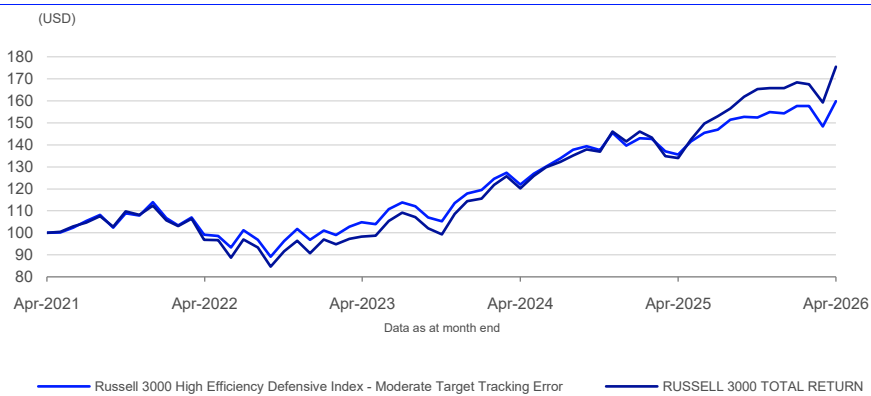


Russell 3000 High Efficiency™ Defensive Index® - Moderate

Objective

The index is calculated based on price and total return methodologies and available end-of-day.
