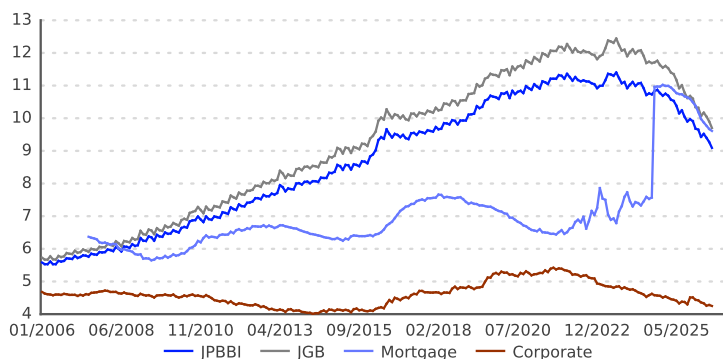
FTSE日本ブロード債券インデックス (JPBBI) は、日本の債券市場で発行される円建て債券のパフォーマンスを測定するものです。これには、日本の機関投資家が投資できる日本で発行される固定利付き債が含まれます。JPBBIは、日本国債 (JGB)、政府関連債、モーゲージ証券、地方債、社債を含みます。本インデックスは幅広いアセット・クラスから構成されており、サブ・インデックスはこれらの様々なアセット・クラス、残存年限、格付けを組み合わせる構成されます。

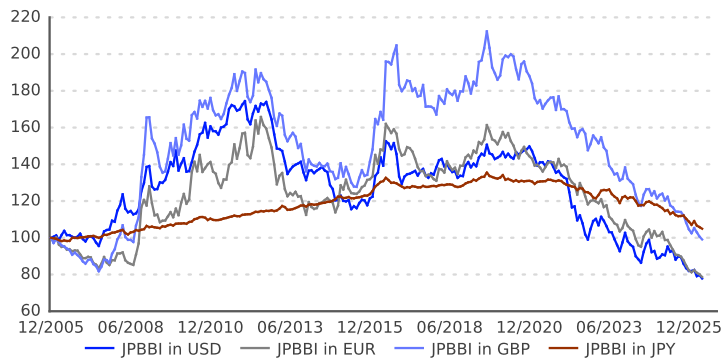
修正デュレーションの推移



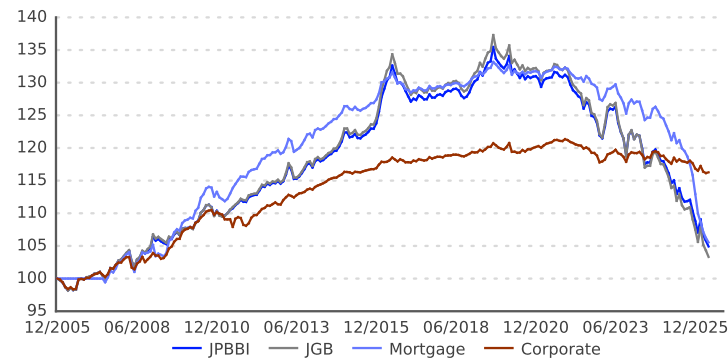
利回りの推移
