The Russell Top 500 Index measures the performance of approximately 500 of the largest companies in the US equity market based on a combination of their market cap and current index membership. The index is reconstituted semi-annually, and newly eligible IPOs are added quarterly, to ensure new and growing companies are represented in this index.

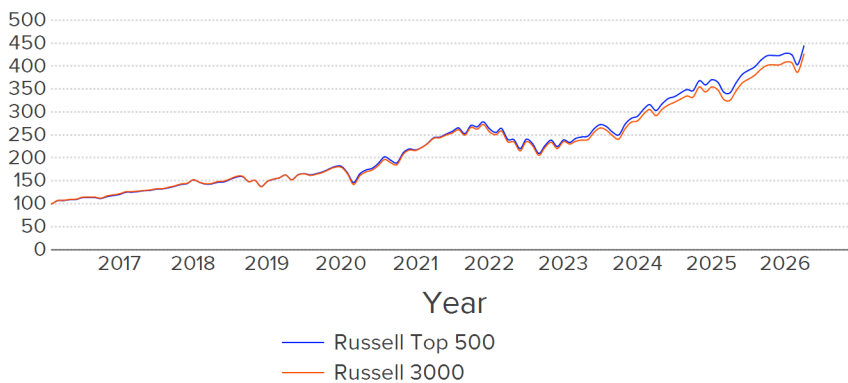

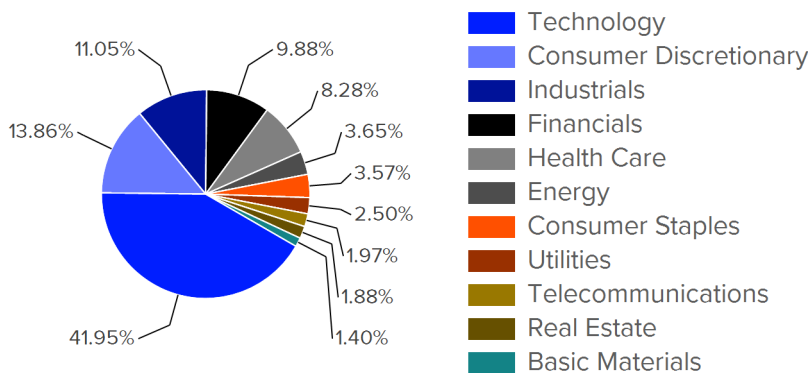
