## About the index

The Russell Midcap® Index measures the performance of the mid cap segment of the US equity market. As a subset of the Russell 1000® Index, the Russell Midcap Index includes approximately 800 non-mega cap companies based on a combination of their market cap and current index membership. The Russell Midcap Index is constructed to provide a comprehensive and unbiased barometer for the US mid cap segment. Semi-annual reconstitution and quarterly IPO inclusions ensure newly eligible companies are represented and that mega cap stocks do not distort the performance and characteristics of the true mid cap opportunity set.

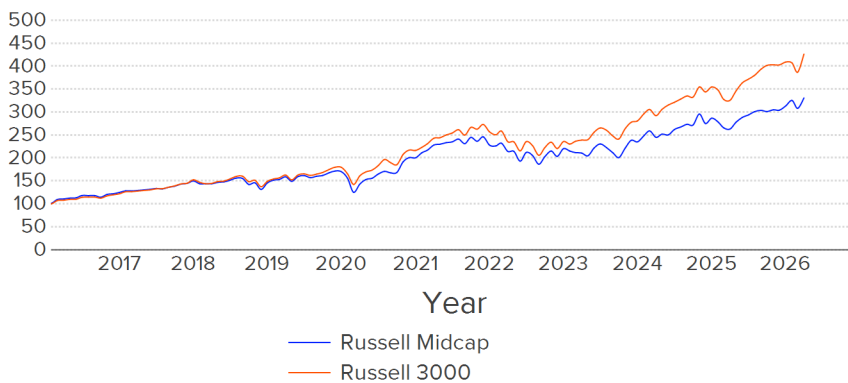

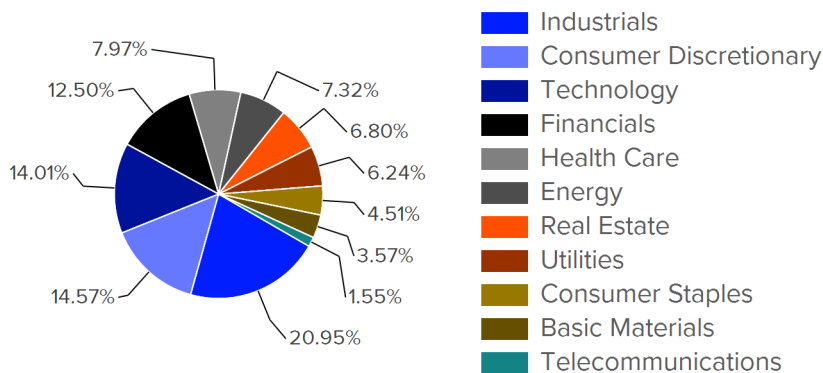
