About the index

The Russell Top 200® Index measures the performance of the mega cap segment of the US equity market. As a subset of the Russell 1000® Index, it includes approximately 200 of the largest US companies based on a combination of their market cap and current index membership. The Russell Top 200 Index is constructed to provide a comprehensive and unbiased barometer for this US mega cap equity segment. The index is reconstituted semi-annually, and newly eligible IPOs are added quarterly, to ensure new and growing companies are represented in this mega cap US equity index.

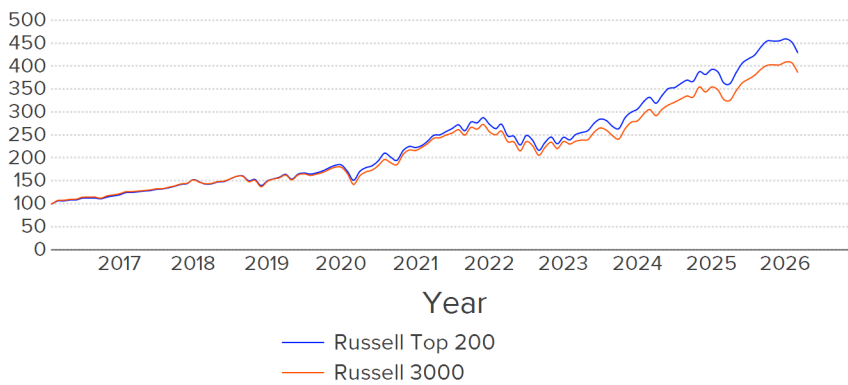

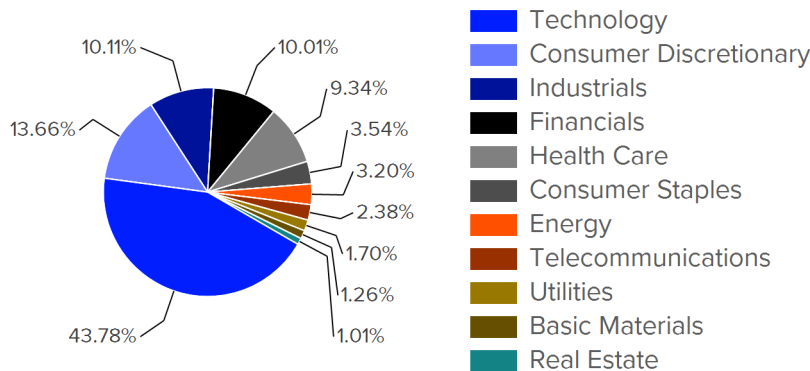
