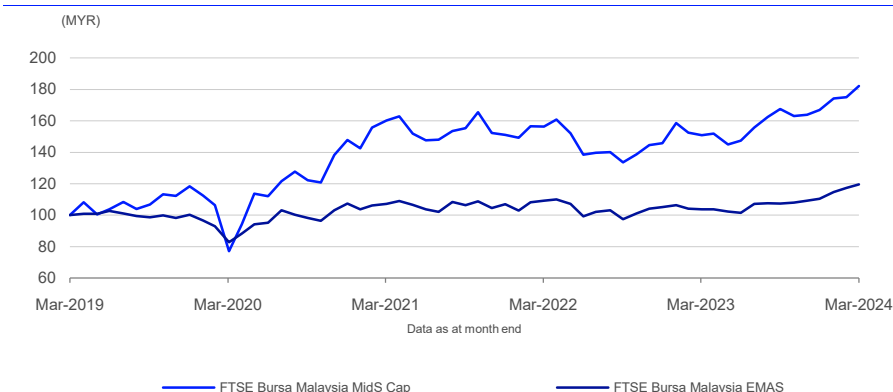


FTSE Bursa Malaysia MidS Cap Index
