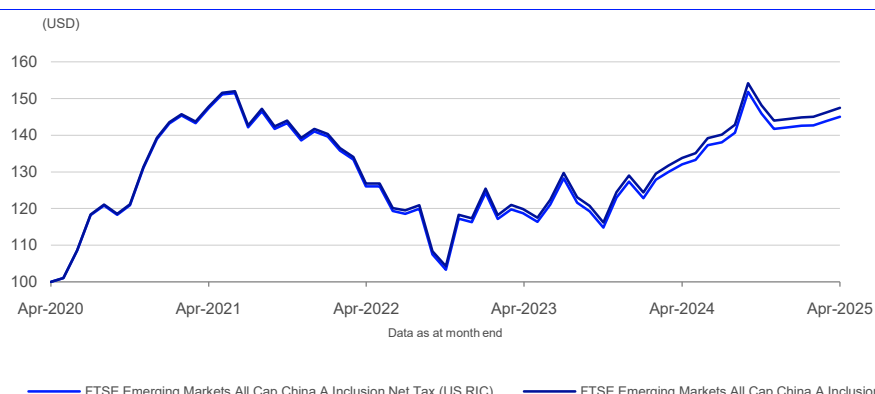


FTSE Emerging Markets All Cap China A Inclusion Net Tax (US RIC) Index
