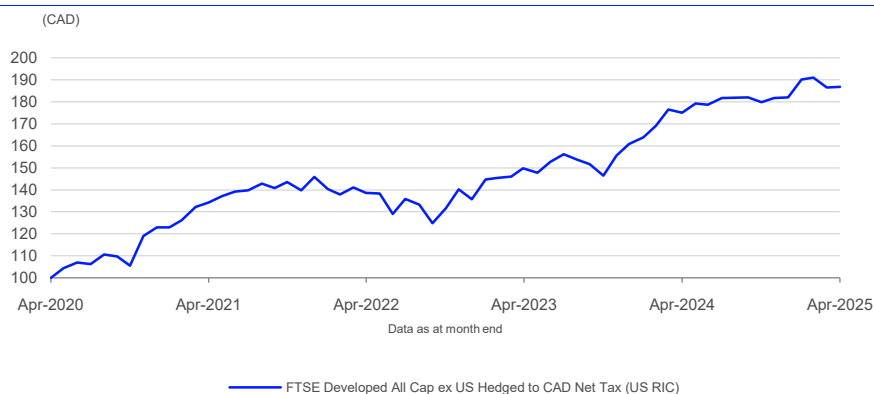


# FTSE Developed All Cap ex US Hedged to CAD Net Tax (US RIC) Index

The FTSE Developed All Cap ex US Hedged to CAD Index is a hedged market-capitalization weighted index representing the performance of large, mid and small cap companies in Developed markets, excluding the USA. The index is derived from the FTSE Global Equity Index Series (GEIS), which captures 99% of the world's investable market capitalization.
