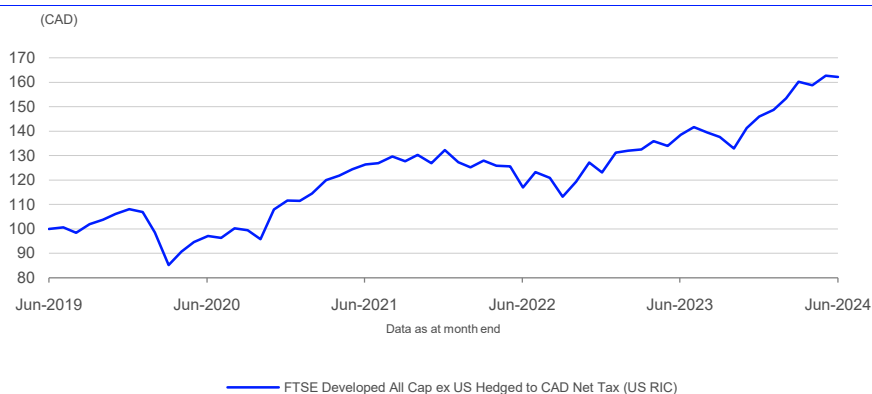


FTSE Developed All Cap ex US Hedged to CAD Net Tax (US RIC) Index

Coverage

The index is calculated based on price and total return methodologies, available end of day.
