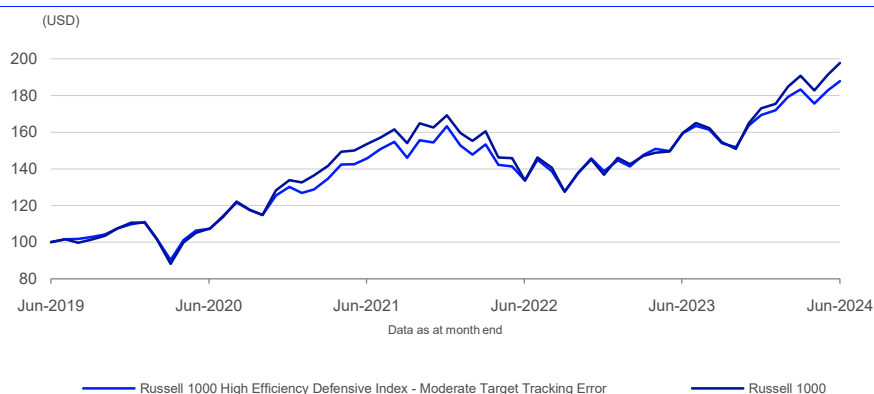


Russell 1000 High Efficiency™ Defensive Index® - Moderate

Objective
