


# FTSE Canada All Cap Domestic Index

The FTSE Canada All Cap Domestic Index is an index designed to provide market participants with a tool to benchmark and analyze the Canadian domestic market. The index can also be used as a tool in the creation of a wide variety of financial products such as index-linked funds and exchange traded funds. The FTSE Canada All Cap Domestic Index is a market-capitalization weighted index comprised of Canadian large, mid and small cap stocks selected from the FTSE Developed All Cap Index, but without applying the FTSE GEIS foreign ownership restrictions when calculating each individual constituent's investibility weight.

#### Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

#### Investability

Stocks are free-float weighted to ensure that only the investable opportunity set is included within the index.

## Liquidity

Stocks are screened to ensure that the index is tradable.

### Transparency

The indexes use a transparent, methodologies-based construction process. Index methodologies are freely available on the FTSE Russell website.

#### **Availability**

The index is calculated based on price and total return methodologies.

#### Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
