Sovereign, Corporate | South African Rand

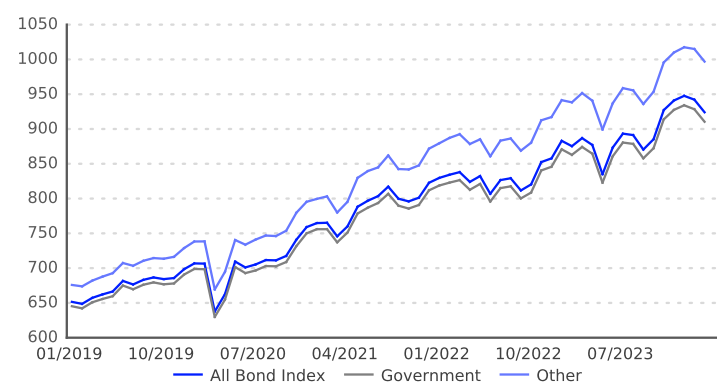

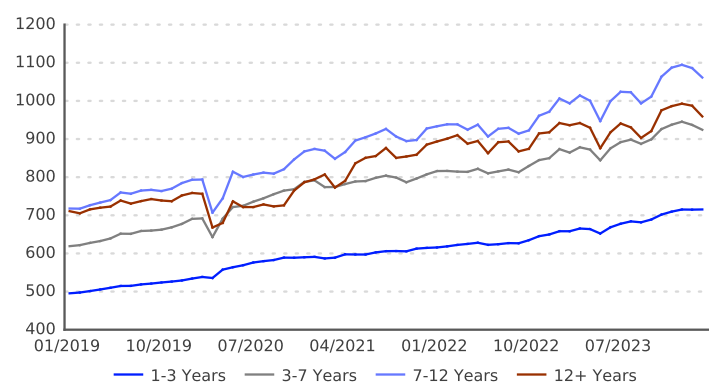
