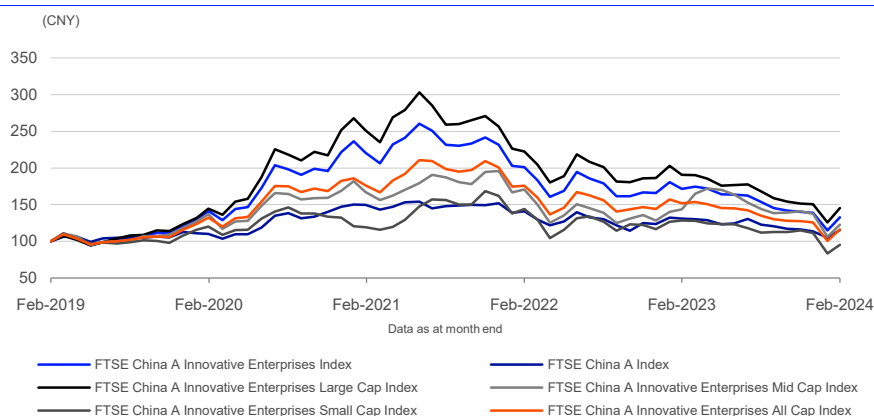


FTSE China A Innovative Enterprises Indices

The FTSE China A Innovative Enterprises Indices are a combination of large/mid/small cap and sector indices that measure the performance of companies listed on the Shenzhen Stock Exchange ChiNext market and Shanghai Stock Exchange STAR market. The index constituents are weighted by free float and restrictions applied to foreign investors.

Objective

The indices are designed for the creation of index tracking funds, ETFs, structured products, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

Index methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and total return methodologies at end of day. Net Total Return indices are also calculated.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
