


# FTSE France 40 Low Carbon ESG Screened / Data as at: 29 March 2024 Decrement 5% / Decrement FEATURES **50 points Indices**

The FTSE France 40 Low Carbon ESG Screened / Decrement 5% / Decrement 50 points has a starting universe of the top 80 largest French companies in the FTSE France Index. From this universe, the top 40 stocks with the lowest carbon emissions are then selected and constituents are equally weighted. The index applies product involvement screens related to fossil fuels, nuclear power, vice products and weapons. The index also excludes companies involved with controversial conduct in relation to the UN Global Compact Principles.

Index methodologies are freely available on the FTSE Russell website.

#### **Availability**

The index is calculated based on price and total return methodologies, both real time and end of day.

#### Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
