The FTSE World Broad Investment-Grade Green Impact Bond Index (WorldBIG Green Impact) constituents are selected from the FTSE World Broad Investment-Grade Bond Index (WorldBIG), screened in accordance with the transparent and defined green bond criteria.

The WorldBIG Green Impact leverages Climate Bonds Initiative (CBI) data to identify eligible Green Bonds whose use of proceeds are in line with the Paris Agreement.






## HISTORICAL EFFECTIVE DURATION




## HISTORICAL YIELD TO MATURITY

Pricing:	Pricing for the WGBI portion of the index: Refinitiv pricing except for: - Israel (provided by Tel Aviv Stock Exchange) - Mexico (provided by Proveedor Integral de Precios S.A. de C.V.) - Poland (provided by BondSpot) - Singapore (provided by the Monetary Authority of Singapore) For the non-WGBI portion of the index: Refinitiv
Rebalancing:	Once a month at month end
Calculation Frequency:	Daily
