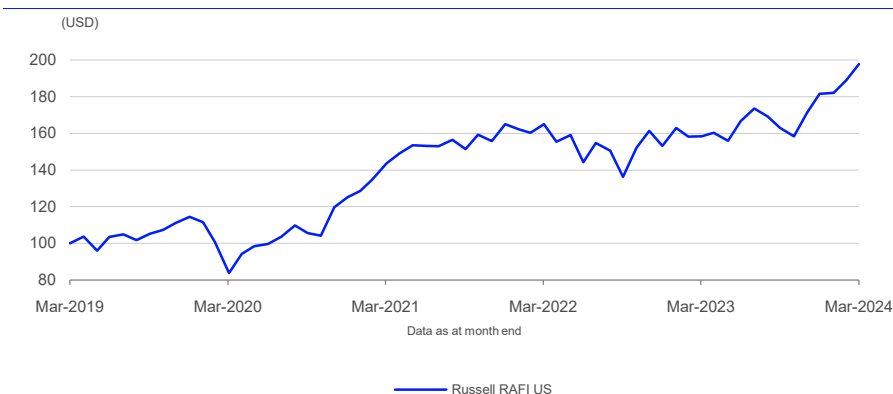


Russell RAFI™ US Index
