## FTSE China 50 Index Review Changes Overview - March 2020

Data as at: 13 March 2020

### Review Overview

The FTSE China 50 Index represents the top 50 Chinese companies (Red Chips, H Shares and P Chips) by market capitalisation trading on the Stock Exchange of Hong Kong. The FTSE China 50 Index is reviewed quarterly in March, June, September and December to ensure the Index remains representative of the underlying Chinese market for international investors.

The following changes will be made to the FTSE China 50 Index after the March review. Effective on Monday 23 March 2020, ZTE (H) (00763) will be included in the FTSE China 50 Index, replacing Air China (H) (00753). The total two-way index turnover is estimated to be 5.53 per cent.

The FTSE China 50 Index Reserve List contains the next 5 highest ranked companies by full market capitalisation – Sunac China Holdings (P Chip) (01918), BYD (H) (01211), Alibaba Health Information Technology (P Chip) (00241), Haitong Securities (H) (06837) and Hansoh Pharmaceutical Group (P Chip) (03692).
