The Russell Top 500 Index measures the performance of the largest cap segment of the U.S. equity universe. The Russell Top 500 Index is a subset of the Russell 3000® Index. It includes approximately 500 of the largest securities based on a combination of their market cap and current index membership and represents approximately 83% of the U.S. market. The Russell Top 500 Index is constructed to provide a comprehensive and unbiased barometer for this large cap segment and is completely reconstituted annually to ensure new and growing equities are reflected.

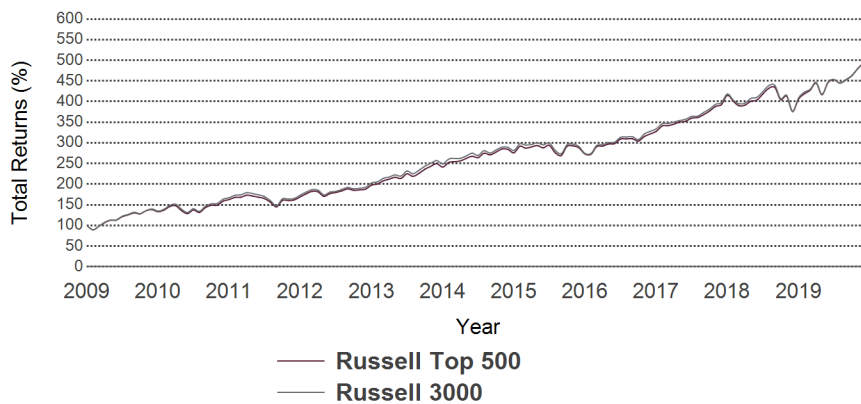

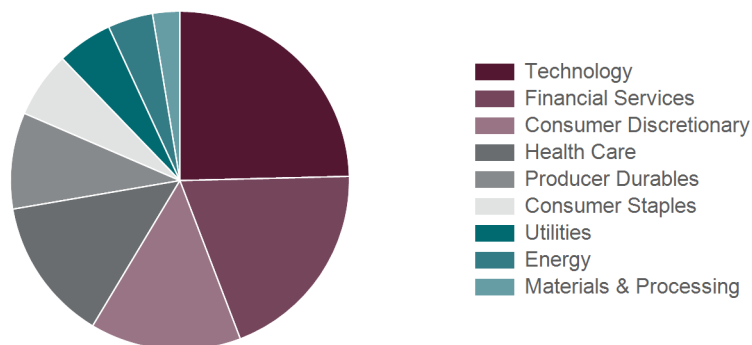
