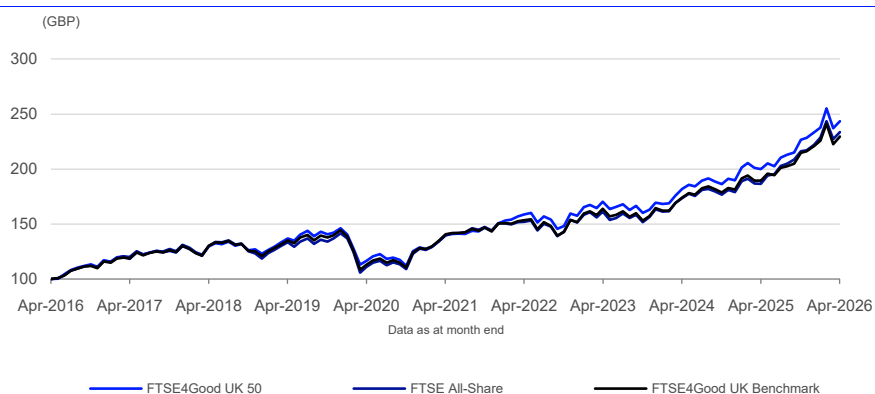


FTSE4Good UK 50 Index
