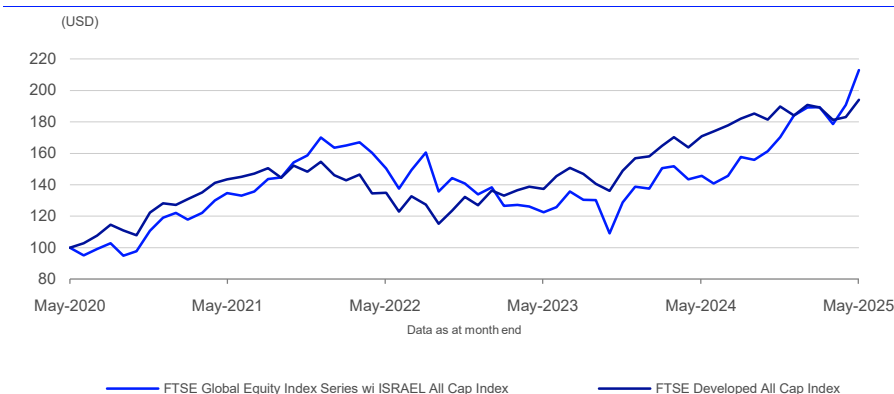


FTSE Israel All Cap Index

The FTSE Israel All Cap Index is part of a range of indices designed to help investors benchmark their investments. The FTSE Israel All Cap index is a market-capitalisation weighted index representing the performance of Israeli large, mid and small cap stocks. The index is derived from the FTSE Global Equity Index Series (GEIS), which covers 98% of the world's investable market capitalization.

Objective

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

Index methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and net total return methodologies with end-of-day pricing.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
