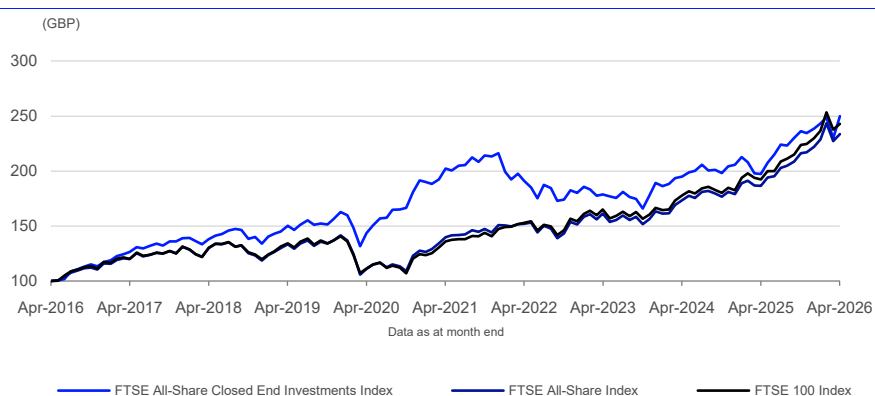


FTSE All-Share Closed End Investments Index
