


FTSE Eurozone Oil & Gas Select 50 Point Decrement Index

Data as at: 30 May 2025

The FTSE Eurozone Oil and Gas Select Index is designed to reflect the performance of mid and large cap Eurozone companies with the largest investable market capitalisations, as defined within the FTSE Eurozone Index and categorized as Oil and Gas in the ICB classification framework. The FTSE Eurozone Oil and Gas Select 50 Point Decrement Index replicates an investment in the FTSE Eurozone Oil and Gas Select Index with a decrement of 50 index points per annum, accruing on a daily basis.

Availability

The index is calculated based on price and total return methodologies, both real time and end of day.
