

# FTSE EPRA Nareit UK REITs and Non-REITs Indices

Data as at: 30 April 2025

The FTSE EPRA Nareit Global Real Estate Index Series is designed to represent general trends in eligible real estate equities worldwide. Relevant activities are defined as the ownership, trading and development of income-producing real estate. The index series now covers Global, Developed and Emerging indices, as well the UK's AIM market.

In response to the UK REIT legislation, which came into force on 1st January 2007, FTSE Group has created a FTSE EPRA Nareit UK REITs Index, and a FTSE EPRA Nareit UK Non-REITs Index. The indices are a subset of the FTSE EPRA Nareit UK Index and gives investors the capability to view each constituent's classification within the EPRA Nareit universe according to REIT legislation.

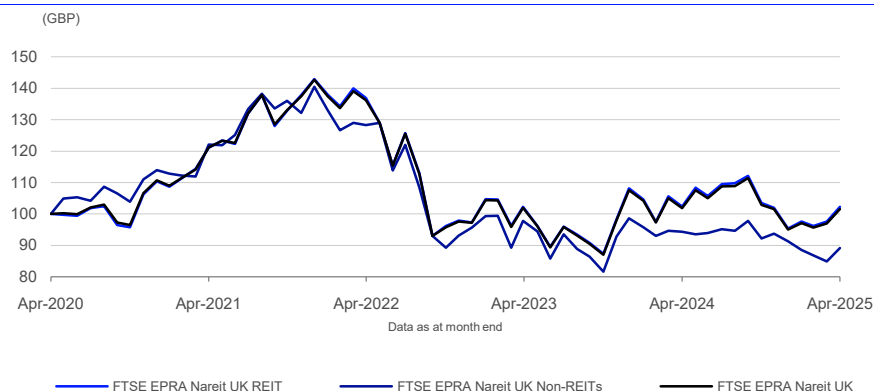
The indices will allow for a more granular assessment of the performance characteristics of UK REITs. By making the constituents of the indices free-float adjusted, liquidity, size and revenue screened, they are suitable for use as the basis for investment products, such as derivatives and Exchange Traded Funds (ETFs).

## Definition of a UK REIT

A real estate investment trust (REIT) is a publicly traded real estate company that owns and may manage investment-grade commercial or residential real estate. REITs provide investors with a liquid and cost efficient way to earn the investment returns typically available from direct real estate investment.

To qualify as a REIT, a real estate company must satisfy certain requirements set forth by UK legislation, including the distribution each year to its shareholders of at least 90% of its taxable income. In return for distributing most or all of its taxable income, the company pays no corporate tax on the distributed income. Rather, the tax liability is paid at the individual shareholder level.

## FEATURES

### Coverage

The FTSE EPRA Nareit UK REITs and Non-REITs Indices are a subset of the FTSE EPRA Nareit UK Index, separating constituents into both REITs and Non-REITs indices.

### Diversified Investment Opportunities

The indexes provides investors with the diversification that real estate offers due to its low correlation with other asset classes, along with sufficient liquidity to gain access to the asset class.

### Objective

The indexes are designed for the creation of index tracking funds, derivatives and as a performance benchmark.

### Investability

Stocks are selected and weighted to ensure that the index is investable.

### Liquidity

Stocks are screened to ensure that the index is tradable.

### Transparency

The indexes use a transparent, methodologies-based construction process. Index methodologies are freely available on the FTSE Russell website.

### Availability

The indexes are calculated based on price and total return methodologies, on an end-of-day basis.

### Property Sector Classification

Constituents are classified into distinct Property Sectors based on gross invested book assets as disclosed in the latest published financial statement.
