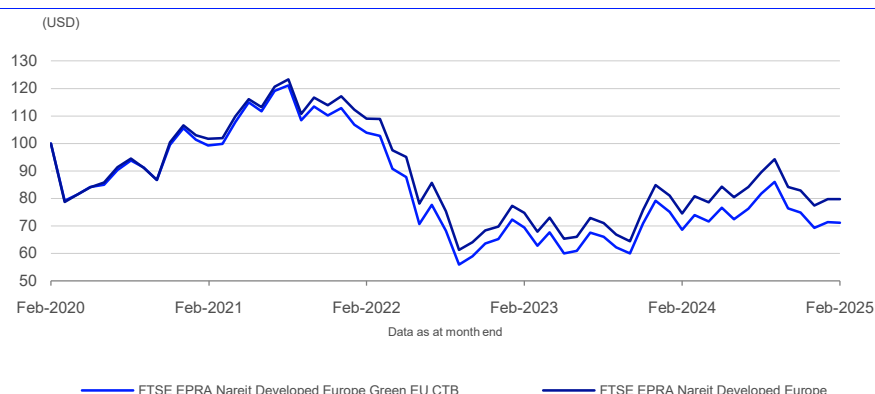


# FTSE EPRA Nareit Developed Europe Green EU CTB Index

Data as at: 28 February 2025

The FTSE EPRA Nareit Developed Europe Green EU CTB Index supports investors wanting to integrate sustainable investment considerations into their listed real estate portfolio. The index is comprised of constituents of the FTSE EPRA Nareit Developed Europe Index and applies exclusions in excess of the minimum PAB exclusions requirements. It sets decarbonisation targets which mirror the economy required efforts to limit global warming to below 2DC. In addition, the index incorporates the following targets: 30% Green certificate increase, 10% energy consumption reduction. Furthermore, industry banding constraints are applied to the index in order to reduce tracking error.
