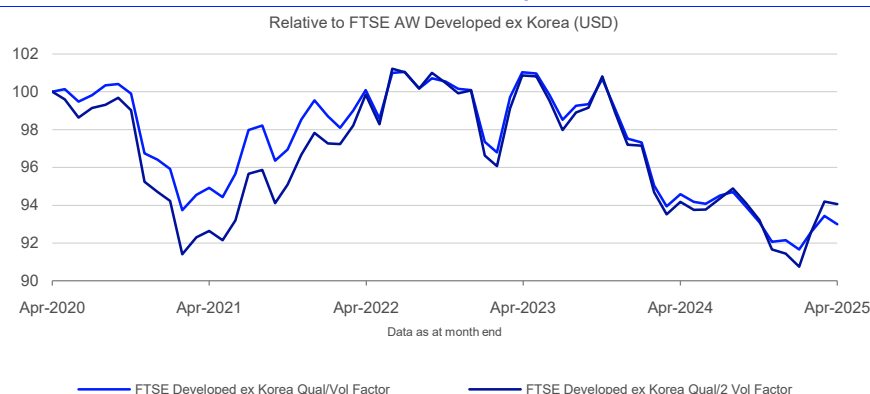


FTSE Developed ex Korea Qual/Vol Factor Indices

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
