

FTSE Frontier Large Mid Cap Vietnam USD Net Tax Index

The FTSE Frontier Large Mid Cap Vietnam is part of the FTSE Frontier Index Series. The index measures the performance of Large and Mid Cap constituents within the FTSE Frontier Vietnam Index. The index aims to capture around 92% of the broader FTSE Frontier Vietnam Index. This index measures the Net Total Return, reflecting the tax adjustment of dividends.

Managed according to a transparent rule set, the index is designed for use as a performance benchmark and for use in the creation of index tracking products.

Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Constituents of the FTSE Frontier Index Series are adjusted for free float and foreign ownership limits.

Liquidity

Each security will be tested for liquidity annually in September by calculation of its velocity trading per month.

Transparency

The indexes use a transparent, rules-based construction process. Index methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and net total return methodologies and available real-time and end-of-day.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
