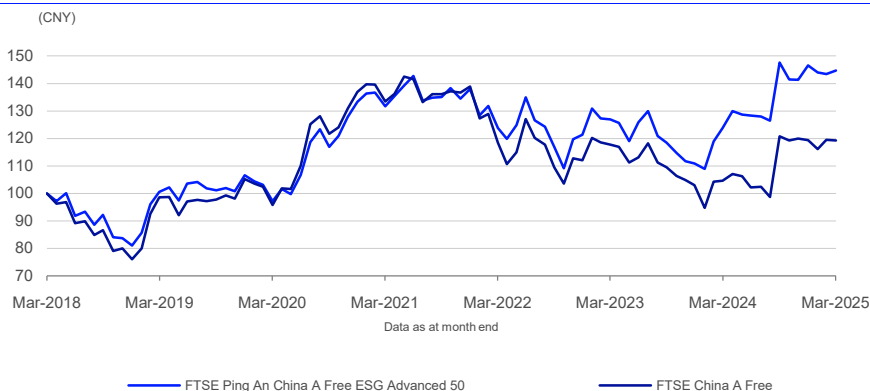


FTSE Ping An China A Free ESG Advanced 50 Index (Chinese)

富时平安中国 A 股自由流通指数系列整合了平安的中国特色 ESG 评分，反映了具有出色环境、社会和治理实践的中国公司的表现。富时平安中国 A 股自由流通 ESG 先进 50 指数从行业分类标准系统（ICB）的 10 个行业（金融和房地产被视为一个行业）中各选择 ESG 评级排名前 5 的公司从最高到最低排名，并按市值对成分股进行加权。该指数基于富时中国 A 股自由流通指数，是中国 A 股市场具代表性的综合基准，涵盖在上海和深圳证券交易所（包括科创板和创业板）上市的大中盘股。

富时平安中国 A 股自由流通 ESG 指数系列将实施流动性筛选，以一年期 ADTV（日平均交易量）为标准。ADTV 排名位于富时中国 A 股全盘自由流通指数最低 20% 的证券将不符合被纳入资格。

权重上限

富时平安中国 A 股自由流通 ESG 指数成分股的权重上限为 10%。

透明性

指数实行透明的、基于规则的构建过程。指数方法论可在富时罗素官网获取。

可用性

指数基于价格和全收益方法计算，日交易结束可获取。
