

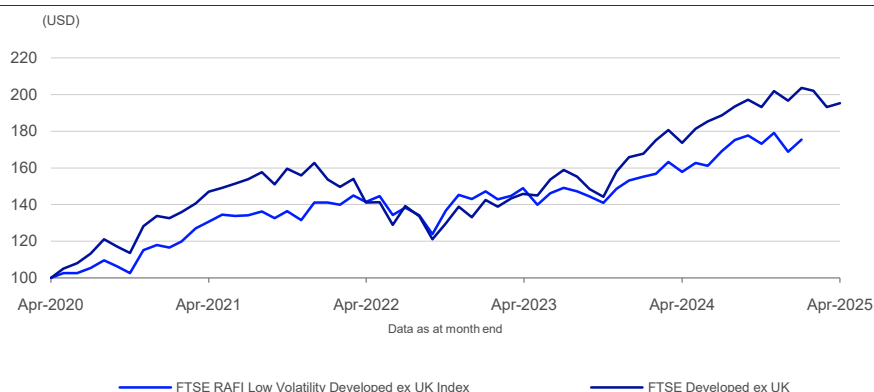
FTSE RAFI™ Developed ex UK Low Volatility Index

Index rules are freely available on the FTSE Russell website.

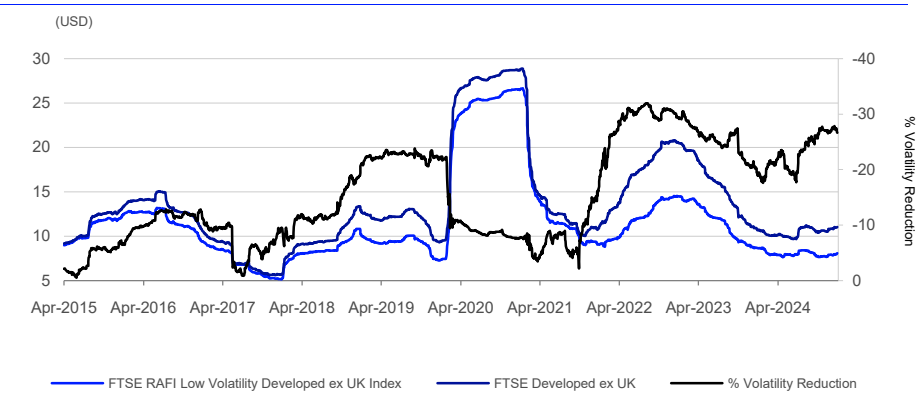
Availability
