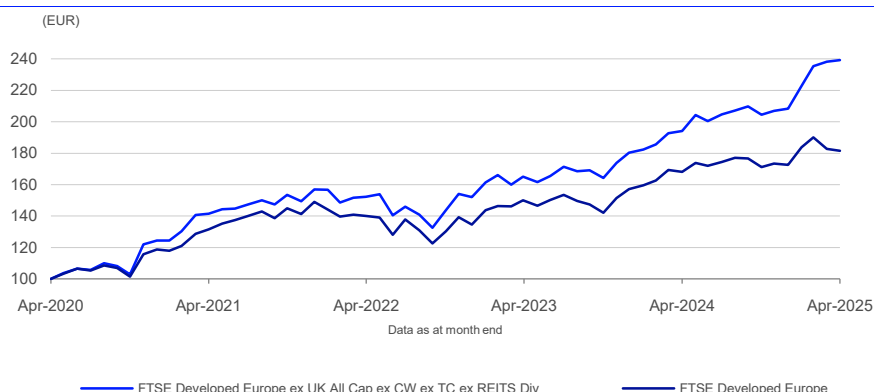


FTSE Developed Europe ex UK All Cap ex CW ex TC ex REITS Dividend Growth with Quality Index
