

# FTSE UK Dividend Yield Select Index

Data as at: 31 March 2025

The FTSE UK Dividend Yield Select Index is designed to reflect the performance of high yielding stocks selected from the FTSE 100 Index.

From the eligible constituents of the FTSE 100, the 40 stocks having the highest upside return are selected. From those 40 stocks, the 20 with the highest dividend yield included in the index, weighted in proportion to liquidity (capped at 10%). The index is reviewed in line with the underlying FTSE 100 index.

## FEATURES

### Coverage

The FTSE UK Dividend Yield Select Index selects 20 stocks from the FTSE 100 Index that display positive momentum and high dividends.

### Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

### Eligibility

Eligible constituents are those in the FTSE 100 Index with an average daily trading volume of greater than 10 million GBP.

### Capping

Constituents are capped at 10% quarterly, with excess weight redistributed in proportion to liquidity.

### Transparency

The index uses a transparent, methodology-based construction process. Index methodologies are freely available on the FTSE Russell website.

### Availability

The index is calculated based on price and total return methodologies, and available end-of-day.

### Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
