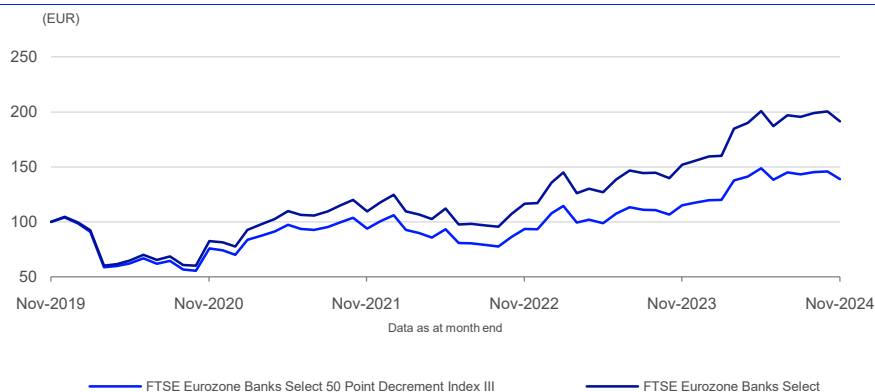


FTSE Eurozone Banks Select 50 Point Decrement Index III

Data as at: 29 November 2024

The FTSE Eurozone Banks Decrement Index is designed to reflect the performance of mid and large cap Eurozone companies with the largest investable market capitalisations, as defined within the FTSE Eurozone Index and categorized as Banks in the ICB classification framework. The FTSE Eurozone Banks Select 50 Point Decrement Index III replicates an investment in the FTSE Eurozone Banks Select Index with a decrement of 50 index points per annum, accruing on a daily basis.

Objective

Stocks in the underlying index are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Index methodologies are freely available on the FTSE Russell website.

Availability

The index is calculated based on price and total return methodologies, both real time and end of day.

Industry Classification Benchmark (ICB)

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
