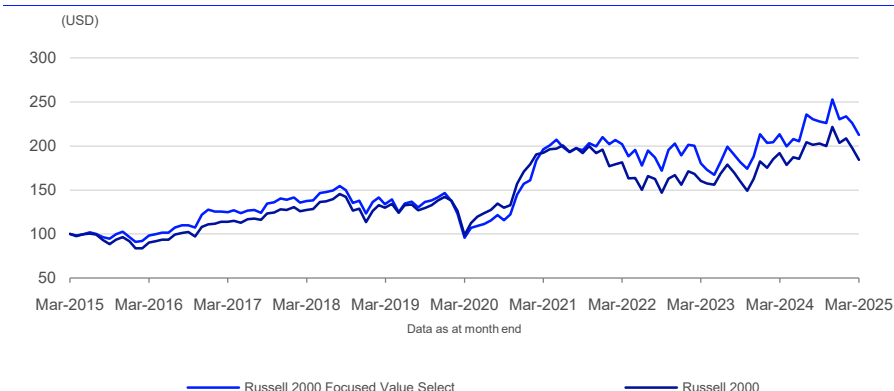


# Russell 2000 Focused Value Select Index

The Russell 2000 Focused Value Select Index is designed to reflect the performance of securities exhibiting the highest value characteristics in the Russell 2000 Index. The index does not take into account ESG factors. It is comprised of the top 250 securities by Composite Score with equal weighting being applied.

Index methodologies are freely available on the FTSE Russell website.

### Availability

The index is calculated based on price and total return methodologies, both real-time and end-of-day.

Index constituents are categorized in accordance with the Industry Classification Benchmark (ICB), the global standard for industry sector analysis.
